

AMENDMENT TO _____
OFFERED BY MS. LUMMIS OF WYOMING

Base text: HR 3962 as posted for Rules

In section 1701(a)(1)—

(1) strike “1902(a)(10)(A)(i)” and insert “1902(a)(10)(A)(ii)”;

(2) strike “1396b(a)(10)(A)(i)” and insert “1396b(a)(10)(A)(ii)”;

(3) in subparagraph (A), strike “(VI)” and insert “(XVIII)”;

(4) in subparagraph (B), strike “(VII)” and insert “(XIX)”;

(5) redesignate subclause (VIII), as added by subparagraph (C), as subclause (XX).

In clause (v) of section 1902(a)(10)(E) of the Social Security Act, as added by section 1701(a)(2), insert “at the option of the State,” before “for making medical assistance”.

In section 1905(y)(1) of the Social Security Act, as added by section 1701(a)(3)(B), strike “subclause (VIII) of section 1902(a)(10)(A)(i)” and insert “subclause (XX) of section 1902(a)(10)(A)(ii)”.

In section 1701(a)(4), strike “subparagraph (A)(i)(VIII)” and insert “subparagraph (A)(ii)(XX)”.

In section 1701(a)(5)(A)(i), strike “(i)(VIII)” and insert “(ii)(XX)”.

In clause (xvi) in the matter preceding paragraph (1) of section 1905(a) of the Social Security Act, as added by section 1701(a)(5)(B)(iii), strike “(i)(VIII)” and insert “(ii)(XX)”.

In section 1701(b)(1)—

(1) in the matter before subparagraph (A), by striking “(A)(i)” each place it appears and inserting “(A)(ii)”;

(2) in subparagraph (A), by striking “(VII)” and inserting “(XIX)”;

(3) by redesignating subclauses (IX), (X), and (XI), as added by subparagraph (B), as (XXI), (XXII), and (XXIII), respectively.

In subclause (XXI) of section 1902(a)(10)(A)(ii), as added by section 1701(b)(1)(B) and redesignated above, strike “subclause (I)” and insert “clause (i)(I)”.

In subclause (XXII) of section 1902(a)(10)(A)(ii), as added by section 1701(b)(1)(B) and redesignated above, strike “subclause (I) or (VII)” and insert “clause (i)(I) or subclause (XX)”.

In subclause (XXIII) of section 1902(a)(10)(A)(ii), as added by section 1701(b)(1)(B) and redesignated above, strike “subclause (X)” and insert “subclause (XXII)”.

In section 1701(b)(2)(A)—

- (1) strike “or (IX)” and insert “or (XXI)”; and
- (2) strike “(VIII)” and insert “(XX)”.

In section 1701(b)(2)(B)—

- (1) strike “(i)(X)” and insert “(ii)(XXII)”; and
- (2) strike “(i)(XI)” and insert “(ii)(XXIII)”.

In section 1701(b)(3), strike “subclause (IX), (X), or (XI) of section 1902(a)(10)(A)(i)” and insert “subclause (XXI), (XXII), or (XXIII) of section 1902(a)(10)(A)(ii)’”.

In section 1701(b)(4), strike “by inserting ‘1902(a)(10)(A)(i)(IX), 1902(a)(10)(A)(i)(X), 1902(a)(10)(A)(i)(XI),’ after ‘1902(a)(10)(A)(i)(VIII),’” and insert “by inserting ‘1902(a)(10)(A)(ii)(XXI), 1902(a)(10)(A)(ii)(XXII), 1902(a)(10)(A)(ii)(XXIII),’ after ‘1902(a)(10)(A)(ii)(XX),’”.

In subparagraph (D) of section 1932(a)(2) of the Social Security Act, as added by section 1701(d), strike “(i)(VIII)” and insert “(ii)(XX)”.
